# Features of the University

Meiji University was founded in 1881. It ranks solidly among the best universities in Japan, consisting of 10 undergraduate schools, 12 graduate schools, and four professional graduate schools. The Graduate School of Governance Studies is located on Meiji University's Surugadai Campus, right in the heart of metropolitan Tokyo, a hub city with contemporary and traditional culture.

## Features of the Graduate School

One of the major objectives of Governance Studies program is to enhance the administrative capacity and governance skills of early-career professionals, mainly from developing nations. Our focus is on governance, public policy, and public management. Toward the goal, enrolled students are focusing on a broad spectrum of issues, such as administrative and fiscal reform, economic development, sustainable development, and community management. They are also encouraged to study varieties of policy-making processes as well as issues in policy implementation and evaluation.

By offering a wide range of subjects for the students to choose from, our Governance Studies program encourages students to specialize further in the theory of public policy, such as governance and policy sciences, or in more pragmatic issues such as government business relationships and intergovernmental interfaces. Students trained to evaluate the role and function of these policy matters from different perspectives. The program is highly interdisciplinary, enabling students to apply various approaches and concepts to political science, economics, and public management. By being exposed to these different fields, students will increase their knowledge of governance and skills for public management.

The first year of the master's program will mainly be devoted to the introduction of certain concepts, theories, and methodologies in the fields of policy public management. sciences and arrangement will help students to deepen their understanding of governance, public management, policymaking, policy implementation, program valuation. In these courses, students are encouraged to participate vigorously in in-class discussions, while they are also expected to conduct their own preliminary research related to their specific policy interests.

In the second year, most students conduct their own research, in addition to attending a few seminar courses that are relevant to their research interests. Each student will have to write a master 's thesis (research paper) paper) by the end of the second year under the supervision of a designated academic advisor. The theme of the thesis may vary according to their interests, such as governance, public management, international finance, urban policy, and social development.

# Features of the Programme

#### **Courses and Three Areas**

The Graduate School of Public Policy offers courses in three concentration areas: Public Policy, International Development Policy, and Community Planning and Management. In each of these areas, major topics of immediate relevance to contemporary world issues including decentralization, "good enough governance," citizen participation, sustainable development, economic development cooperation, regional development, and poverty reduction are discussed in a wide range of courses offered by our faculty members.

#### 1) Public Policy:

This area is about public policy processes, from identifying issues to formulating, implementing, and evaluating policy options. The knowledge and expertise in policy processes, including theories in political science, public administration, and organizational management fields, are growing their importance in the field of public policy.

## 2) International Development Policy:

Drawing on disciplines concerned with international economics and the environment, this focal area encourages students to analyze global issues of sustainable development and poverty reduction from different perspectives on social systems. While market-driven development policies have achieved economic prosperity in many societies, they have also exacerbated global problems such as environmental degradation and income disparity.

#### 3) Community Planning and Management:

Community is the field of practice where governance comes most closely in contact with people's lives. Community Planning and Management area is organized around the process of making, implementing, and evaluating policies for resolving global issues from local perspectives. It also focuses on crisis management and the role of the community in responding to natural disasters and terrorism, which have been increasing in recent years.

#### Research Paper

In order to obtain the Master's degree from Meiji's Graduate School of Governance Studies, students are required to submit a "research paper." Each international student is assigned to a "zemi" group supervised by one of the faculty members and receives hands-on guidance for conducting research and writing the paper.

#### - Research Method

In these seminar courses, first-year students choose a governance public administration-related topic and conduct their own research. Students will acquire skills for theoretical studies and policy analysis by reviewing the relevant literature. This process will guide the student toward the appropriateness of their definition of the topic.

#### - Research Paper

These seminar courses focus on writing academic papers. Each of the second—year students learns to construct a theoretical framework and employ research methods, data analysis techniques, and related skills for writing a research paper on his or her own research topics.

### - Thesis Workshop

Thesis workshops are organized for all Graduate School of Governance Studies international students. This workshop provides students with an opportunity to critique one another's work and engage in an intellectual exchange on their approach to governance studies and their theoretical and research procedures.

### - English Language Academic Writing

We offer a range of English academic communication and writing support courses, workshops and tutoring for international students whose first language is not English. These are taught by native speaking instructors, experienced in English academic support course development.
